Candidates



wants to get benefits of reservation under EWSs reservation should send the scan copy of the certificate as attachment of the email and mention following details in the body text of same email: Application ID, Subject, Name, Category, Name of the University (from where completed graduation) and contact number.

- 3. A candidate must appear in person at the counselling venue for allotment of seat for admission in his/her favour.
- 4. Counselling as per the declared schedule shall continue till availability of seats for admission. The counselling of a particular category will be declared closed instantly as soon as all seats for admission in that category are filled up. No further queries in this regard will be entertained.
